3. It is the responsibility of all members to protect and safeguard the property and equipment of the Society.
4. Members are responsible for the actions of their guests while on the premises.
5. It is the responsibility of all members to attend the membership meeting. Only members whose dues are up-to-date can vote, all members can speak, bring suggestions to the floor and take part in discussions at meetings.
6. All members shall assist the officers with execution of their duties and maintain an orderly operation.
7. On events and club affairs, the members should take a rear seat and be obliging to the guests.
8. In the event any of our members or guests is behaving in a disorderly manner or a disturbance is in the making, it is the responsibility of the members present to quiet it down and not to aggravate the situation any further.
9. Pay your dues on time (by the end of December of the same year) and show your membership card "willingly" to our doorman(s) or special officer on duty upon request.
10. Make yourself available for nomination to an elected officer where you may be qualified in that area.
